To concentrate our efforts on student engagement, Instagram emerges as the optimal platform. Our DVP Teams exclusively operate on Instagram, aligning seamlessly with our strategic objective of connecting with Missouri DECA members through social media. Our focus includes proactive interactions such as reposting member content, responding to queries, and more—a task efficiently handled by our SAT and DVP Teams, resulting in a commendable increase of 321 followers on Instagram this year.

Conversely, we observe a decline in followers on Facebook and Twitter, attributed to the distinct target audiences on these platforms. Facebook primarily caters to advisors, parents, and alumni, while Twitter is predominantly utilized by chapters and advisors. The transition from Twitter to X led to a noticeable decrease in engagement. Nevertheless, we remain committed to leveraging both platforms effectively to disseminate information and raise awareness about DECA across diverse audiences.

In 2024, our focus is on implementing a more strategic plan to further engage members through our social media channels.
